- Providing technical assistance on development of County Wraparound Plans
- Attending/facilitating meetings with community partners, other county departments, etc. regarding the Wraparound Program
- Working directly with counties to obtain approval of County Wraparound Plans
- Processing State/County MOU for Wraparound
- Providing Wraparound Overview Training
- Coordinating with counties to ensure they receive the required training through UC Davis
- Answering questions, issues, or concerns via email or telephone
- Providing assistance, as needed, with Mental Health Services Act requirements for Wraparound
- Providing assistance with regulations, laws, and legislative bills
- Conducting site visits to monitor Wraparound fidelity
