SUBJECT: REGIONAL RECRUITMENT AND TRAINING NETWORKS

The Recruitment, Training and Retention Unit of the California Department of Social Services (CDSS) is requesting your voluntary participation in a collaborative effort to assist counties with the recruitment, training and retention of foster and adoptive parents. This will be achieved through the development of the Regional Recruitment, Training and Retention Networks. The development of these networks will assist CDSS and counties in achieving compliance with Title 42 United States Code Section 622 (b)(9). This section requires states to develop programs that provide for the diligent recruitment of potential foster and adoptive families that reflect the ethnic and racial diversity of children in the State for whom such homes are needed.

The networks will be organized by geographical regions and consist of representatives from the recruitment and training units of local county welfare and probation departments as well as, representatives from Community Care Licensing, State adoption district offices, local community colleges and California foster parent associations. Each regional collaborative will be responsible for the development of strategies to enhance the recruitment, training and retention of foster and adoptive parents, and will develop goals and objectives to ensure success of the mission. The overall objective will be common to all the networks. Each region will develop and implement goals and objectives specific to the needs of its geographical area.

I am sure that we all agree that it is imperative that a substantial pool of licensed foster parents and potential adoptive parents are available to provide care for children requiring temporary out-of-home placement or transitioning to permanency. Additionally, it is of equal importance that all foster and adoptive parents receive training that will provide them with the knowledge necessary to address the unique psychological/physiological needs of the children in their care. It is also crucial that adoptive and foster parent training is provided on an ongoing basis to enhance and maintain a high level of skill and expertise in addressing the needs of children and families in crisis situations. We look forward to your much-needed support for the regional network. The development of

regional networks will open the lines of communication and increase opportunities to develop and share strategies and best practices to provide families for children and youth and to increase community support.
