The purpose of this ACL is to provide County Welfare Departments (CWDs) with the target number of extensions estimated for the WTW 24-Month Time Clock for the July 2015 through December 2015 period. For background regarding the methodology used in estimating the attached extension targets, the methodology and estimated extensions for the previous six month period were released in ACL 15-02, dated January 9, 2015.

Attachment A provides the base population that meets the conditions in the referenced methodology and the corresponding number of available 20 percent extensions in each CWD for the period from July 2015 through December 2015.

If a CWD disagrees or has more relevant data to support different target figures, the CWD shall submit data and arguments to SB104120Percent@dss.ca.gov, within thirty days of the release of this ACL.
