CHILD CARE, TRANSPORTATION, AND SUPPORTIVE
SERVICES COSTS

This letter is to inform counties of their one-time distribution of the TANF ECF funds. The distribution displayed on the attachment represents 50 percent of the state-earned TANF ECF funds for the Stage One Child Care, transportation and supportive services expenditures for services provided to participants in the TANF ECF SE program.

As instructed in [CFL No. 10/11-38](#), counties submitted expenditure information for the supportive services provided to TANF ECF SE participants for September 2009 through September 2010, as well as Federal Fiscal Year (FFY) 2007 and FFY 2008 base year information for counties, as applicable. These submittals, along with the expenditures from community colleges, determined that the state earned \$30 million of TANF ECF funding, of which \$15 million or 50 percent is being distributed to counties.

In consultation with the County Welfare Directors' Association, the distribution of the \$15 million displayed in the attachment was based on a percent-to-total of each county's expenditures above their base requirement. Those who did not meet their base requirement were excluded from the distribution. These funds must be spent toward the 2.5 percent county share of the CalWORKs program grant costs beginning with the October 2012 grants through September 2013. If a county is unable to expend all of these funds for that time period, the California Department of Social Services will

work with the county on a case-by-case basis. Counties can anticipate payment of these funds by the end of 2013.
