This letter informs counties of the Fiscal Year (FY) 2015-16 allocation for Non-Medical Out-of-Home Care (NMOHC) certification costs related to the Supplemental Security Income/State Supplementary Payment (SSI/SSP). A total of \$354,000 General Fund (GF) is available based on the Budget Act of 2015, as shown in the attachment.

The FY 2015-16 NMOHC administrative allocations were distributed based on a percent to statewide total of the FY 2014-15 NMOHC revised allocation amounts. For further details on the percentages, please refer to [County Fiscal Letter No. 14/15-59](#).

Administrative costs associated with the NMOHC funds are to be reported on the County Expense Claim to Program Code 135 (SSI/SSP Out-of-Home Care). Costs exceeding the GF allocation will be shifted to county-only funding using State Use Only Code 833.
