Pursuant to the Budget Act of 2014, this letter provides counties with a planning allocation for \$2.1 million in unspent Fiscal Year (FY) 2014-15 Commercially Sexually Exploited Children (CSEC) Program allocation funds which have been reappropriated to FY 2015-16. The California Department of Social Services will release the final rollover allocation after the FY 2014-15 year-end closeout.

The attachment provides county specific unspent funding for FY 2014-15. In consultation with the County Welfare Directors Association, the unspent funding for FY 2014-15 includes a county specific two percent holdback for anticipated FY 2014-15 supplemental claims. The final FY 2014-15 unspent funding will roll into the FY 2015-16 CSEC program allocation. Counties will have through June 30, 2016, to expend these

Revised Claiming Instructions

Counties should claim expenditures for training provided to commercially sexually exploited youth and specialized prevention and intervention services and support directly provided to commercially sexually exploited youth to Program Code (PC) 918 - CSEC Youth Training, Services and Support. Updates to the PC Description are bolded below:

PC 918 (CSEC Youth Training, Services **and Support)**

The individual child's case plan shall be the basic guideline for the provisions of the child welfare services. Activities include direct delivery of services to CSEC and youth at risk of being trafficked associated with the CSEC Program. This may also include training foster children to help recognize and avoid commercial sexual exploitation; engaging survivors of commercial sexual exploitation to provide support to county staff who serve children who are victims of commercial sexual exploitation and serve as advocates for and perform outreach and support to children who are victims of commercial sexual exploitation; consulting and coordinating with homeless youth shelters and other service providers who work with children who are disproportionately at risk of, or involved in, commercial sexual exploitation, including but not limited to lesbian, gay, bisexual and transgender youth organizations, regarding outreach and support to children who are victims of commercial sexual exploitation; **and the hiring of trained and specialized county staff to support victims, their caregivers, and the interagency and cross-departmental response pursuant to [Welfare and Institutions Code \(W&IC\) 16524.7\(a\)\(4\)\(D\)](#).**

Additional specialized prevention and intervention services for children of this population can include, but are not limited to:

- Specialized counseling,
- Tattoo removal,
- Seeking and obtaining specialized housing,
- Emergency Housing/Shelter Assistance (for example, vouchers, rental or utility deposits, furniture such as beds, couches, dressers, lighting, refrigerators, and other necessary furniture for the health and safety of CSEC youth and their families),
- Addressing gang affiliation,
- Reproductive health education/healthy relationships education,
- Legal assistance,
- Pregnancy/Parenting Services,

- Financial education training,
- Vocational, life skills and other identified CSEC trainings, and
- Stipends for participating in identified trainings.

Time Study Instructions

Effective the date of this CFL, a Time Study Code (TSC) has been established for PC 918 to allow for social workers that are trained and specialized to work with children who are victims of commercial sexual exploitation to support victims and their caregivers, and to provide case management to support interagency and cross-departmental response pursuant to W&IC 16524.7(a)(4)(D).

Social workers should continue to claim other case management activities to the existing child welfare services PCs as appropriate. Expenses for administrative activities related to development of the interagency protocol and multidisciplinary team should continue to be claimed to PC 920 – CSEC Protocol & Development. Expenses for administrative activities under the Federal Preventing Sex Trafficking and Runaway provisions related to identifying, documenting and determining appropriate services for children and youth who are victims or at risk of sex trafficking, including human trafficking screenings, referrals to services and completing required reports for law enforcement, should continue to be claimed to PC 928 in accordance with [CFL No. 15/16-41](#).

As a reminder, pursuant to W&IC section 16524.7(b), funds for the state CSEC program shall not supplant funds for existing programs.
