OPPORTUNITY AND RESPONSIBILITY TO KIDS PROGRAM

This letter informs counties of a funding redistribution of \$6.7 million General Fund for the Fiscal Year (FY) 2015-16 California Work Opportunity and Responsibility to Kids (CalWORKs) Mental Health (MH) and Substance Abuse (SA) allocations. These funds are being redistributed as requested by the County Welfare Directors Association (CWDA). The CWDA determined the redistribution of funding amongst counties to ensure the maximum expenditure rate of available funds.

Attachment I displays the redistribution of FY 2015-16 funds for the CalWORKs MH and SA Program.

Counties are reminded that the legislative authority for counties to redirect funds from their CalWORKs MH and SA allocations to their CalWORKs Single Allocation to fund other CalWORKs employment services expired on June 30, 2014.

As displayed in [County Fiscal Letter \(CFL\) No. 15/16-15](#), costs reported to Program Codes (PC) 625 (CalWORKs MH Services) and 628 (CalWORKs SA Treatment) will be charged against these allocations. Expenditures that exceed the total allocation will be transferred to county share using State Use Only PC 632 (CalWORKs SA/MH Treatment).
