SUBJECT: FISCAL YEAR 2016-17 STATE KINSHIP GUARDIANSHIP  
ASSISTANCE PAYMENT ADMINISTRATION ALLOCATION

The purpose of this letter is to inform counties of the Fiscal Year (FY) 2016-17 allocation for the state-funded Kinship Guardianship Assistance Payment (Kin-GAP) Administration as identified in the attachment.

Kin-GAP is a payment program for eligible dependents and wards whose dependencies have been dismissed after their relative caregiver has assumed legal guardianship. It is intended to enhance family preservation and stability by recognizing that many foster children are in long-term, stable placements with relatives, and these placements are the permanent plan for the child.

A total of \$3.7 million General Fund (GF) is available based on the Budget Act of 2016, as identified in the attachment.

In consultation with the County Welfare Directors Association, the funding is distributed to counties based on a percent to statewide total of each county's FY 2015-16 state Kin-GAP allocation. The amounts displayed on the attachment reflect the FY 2016-17 appropriation allocation.

This allocation is provided for administrative activities associated with the existing state-funded Kin-GAP program, inclusive of nonminors who receive extended benefits past aged 18.

Counties should claim costs to Program Code (PC) 030 State Only Kin-GAP; PC 031 Kin-GAP/Non-Federally Eligible and PC 847 Over 18 Kin-GAP Non-Federally Eligible

Expenditures exceeding the GF allocation will be shifted to county-only funding via State Use Only (SUO) Code 044, SUO-Non-Fed KinGAP.
