SUBJECT: ASYLEES TIME ELIGIBILITY FOR REFUGEE CASH ASSISTANCE –
JUNE 15, 2000 RULING

The purpose of this All County Information Notice is to offer additional clarification of the June 15 ruling by the federal Office of Refugee Resettlement that asylees are time eligible for Refugee Cash Assistance (RCA) beginning with the date asylum is granted

As of June 15, 2000, any asylee who has received or applied for RCA on or after June 15, 2000, is now time eligible for RCA benefits for eight months from the date asylum was granted.

As an example, any individual whose asylum was granted November 1, 1999 is eligible for benefits for the month of June 2000. However, in order to receive the benefits, the individual must apply for RCA on or after June 15. The benefits are granted from the date of application forward (June 15 until date of time expiration of June 30). In calculating the time eligibility, November is counted as the first month of asylee eligibility, which is continued through to the end of June, for a total of eight months.

Attached is a chart to assist in calculating the eight-month time eligibility period for asylees under the new ruling.
