SUBJECT: **INVITATION FOR COUNTY ADOPTION AGENCY PARTICIPATION
(ICP) IN OLDER YOUTH ADOPTIONS (OYA) PROJECT**

The California Department of Social Services (CDSS) is pleased to announce that on July 12, 2006, Governor Schwarzenegger signed into law Assembly Bill 1808 (Chapter 75, Statutes of 2006) authorizing a project to increase successful adoptions of older foster youth. Under the provisions of this law, San Francisco City and County will receive \$750,000, Los Angeles County will receive \$1.25 million and one CDSS Adoptions District Office will receive additional positions to serve smaller counties. The Sacramento District Office has been selected for these positions. The CDSS is authorized to appropriate a total of \$1.7 million to be divided between two counties for expenditure over three years.

REQUIREMENTS OF THE PROJECT

The following are key requirements of the project as specified in the enabling legislation:

- Target “children and youth who have been in foster care 18 months or more, are at least nine years of age, and are placed in an unrelated foster home or in a group home.”
- Direct CDSS, in consultation with the County Welfare Directors Association (CWDA), to select two additional counties.

- Provide that funding for the project shall be used to supplement, not supplant other federal, state and local funds and must be used as specified in Welfare and Institutions Code Section 16124.
- Require CDSS to work with the participating counties to develop the requirements of the project.
- Provide that the county shall implement the project only after adoption of a resolution of support by the county Board of Supervisors.

APPLICATION PROCESS

Any county child welfare agency that is licensed to provide adoption services may apply to participate in this project.

Notice of Intent to Apply: Counties planning to apply should fax the enclosed form entitled "Notice of Intent to Apply for Participation in the Older Youth Adoption Project" to CDSS by **October 11, 2006**. This will assist CDSS in preparing to score proposals in a timely manner.

Applications: To apply for these funds, please submit the attached application, including a budget which allocates the funding over the three years and identifies any anticipated federal or other funds that will be used for the project. Applications must clearly address the required elements of the project. Criteria and scoring information is included along with the application. Also enclosed is a report based on CWS/CMS data showing, by county, the percentage of youth eligible for services through this project.

Please note that applications must be received (either postmarked or hand-delivered) at the CDSS Child and Youth Permanency Branch no later than **5:00 P.M. on November 17, 2006**. See ATTACHMENT B for details.

Scoring of applications: Applications will be scored by a team consisting of CDSS and non-county representatives.

Notification of counties selection: Notification will occur no later than **November 30, 2006**.

RESPONSIBILITIES OF SELECTED COUNTIES:

- Identify a project manager.
- Participate in developing project requirements, collecting and reporting required project data, and utilizing the funds to increase adoptions as required by the legislation.
- Submit evidence of a resolution by the County Board of Supervisors approving the project.

INFORMATION CALL:

To assist counties in developing their proposals, the CDSS has scheduled an informational conference call on Wednesday, **October 18, 2006, at 2:30 P. M.** See ATTACHMENT B for detailed instructions. During this call, CDSS staff will be available to answer questions concerning the preparation of applications for the funds. The OYA Project will focus on children and youth who have been in foster care 18 months or more, are at least nine years of age, and are placed in an unrelated foster home or in a group home.

Timeline for Application Requirements

Here are the steps for the application process:

1. **October 11, 2006** - Fax ATTACHMENT A, Notice of Intent to Apply for Participation in the Older Youth Adoption (OYA) Project.

4. On or before **November 30, 2006** - Notice of Intent to Allocate Funds - A selection team consisting of CDSS and non-county County Welfare Directors Association (CWDA) representatives will have reviewed and scored the applications to determine the two counties for participation in the project.

5. **December 7, 2006** - Last day to submit appeal.

6. **January 2, 2007** - Funds expended following receipt of evidence of a County Board of Supervisors resolution indicating approval of the project.

Appeal Process

After the counties have been selected a Notice of Intent to Allocate Funds will be posted in the lobby of CDSS, located at 744 P Street, Sacramento, California, for a minimum of five (5) calendar days. On that date the Notice of Intent to Allocate Funds will also be e-mailed to each county contact person listed in the Application.

Applicants have five (5) calendar days from the date that the Notice of Intent to Allocate Funds is posted to protest the proposed allocation and to inform CDSS. A Letter of Intent to Appeal must be received by CDSS during the five (5) day posting period. If, prior to the allocation, an applicant files a Letter of Intent to Appeal, the applicant's funds shall not be allocated until either the appeal has been resolved or CDSS has decided the matter.

After filing the Intent to Appeal Letter, the county has five (5) calendar days to submit a Detailed Appeal Statement specifying the ground(s) for appeal with CDSS. Appeals shall be limited to the following conditions:

- A. The CDSS failed to include the following information in the application package.
 1. A clear, precise description of the work to be performed or services to be provided, or
 2. A description of the format which applications shall follow and the elements they shall contain, or
 3. A clear, precise description of the standards the CDSS will use in evaluating the applications, or

4. The date on which applications are due, or
5. The timetable the CDSS will follow in reviewing and evaluating the applications.

AND/OR

B. Applications were not evaluated and/or the funds allocated in the following manner:

1. All applications meeting formal requirements were not reviewed to determine which applications met the content and format requirements specified in the ICP, or
2. All applications meeting the formal requirements were not submitted to the CDSS raters which scored each application using the Selection Criteria specified in the ICP, or
3. All applications and all scoring sheets were not made available for public inspection at the conclusion of the scoring process, or
4. The funds were not allocated in accordance with the application scoring system specified in the ICP.

AND/OR

C. The CDSS failed to correctly apply the standards for reviewing the format requirements or evaluating the applications as specified in the ICP.

AND/OR

D. The CDSS used the evaluation and allocation process (described in B) but failed to follow the methods for scoring the applications as specified in the criteria.

AND/OR

E. The CDSS used the scoring and allocation process (described in B) but is proposing to allocate the funds to an applicant other than what was determined in accordance with the criteria.

Both the *Letter of Intent to Appeal* and the *Detailed Appeal Statement* must be submitted by regular mail, fax, courier or personal delivery to the CDSS address listed on page 1.

Relevant Provisions of Assembly Bill 1808

Welfare and Institutions Code 16124.

- (a) (1) Upon the appropriation of funds by the Legislature for the purposes set forth in this section, the State Department of Social Services shall establish a project in four counties and one state district office of the department to provide preadoption and postadoption services to ensure the successful adoption of children and youth who have been in foster care 18 months or more, are at least nine years of age, and are placed in an unrelated foster home or in a group home.
 - (2) The participating entities shall include the following:
 - (A) City and County of San Francisco.
 - (B) County of Los Angeles.
 - (C) Two additional counties and one state district office, based on criteria developed by the department in consultation with the County Welfare Directors Association, which shall demonstrate geographic diversity.
 - (3) A county that elects to apply for funding pursuant to this section shall submit an application to the department no later than a date determined by the department to ensure timely allocation of funds. The department shall review the applications received, and select the eligible counties in accordance with this section.
- (b) Each entity identified pursuant to paragraph (2) of subdivision (a) shall receive funding to provide preadoption and postadoption services to the adoptive parents and the targeted population identified in paragraph (1) of subdivision (a).
 - (1) Preadoption and postadoption services for the child and each family may include, but shall not be limited to, all of the following:
 - (A) Individualized or other recruitment efforts.
 - (B) Postadoption services, including respite care.
 - (C) Behavioral health services.
 - (D) Peer support groups.
 - (E) Information and referral services.
 - (F) Other locally designed services, as appropriate.
 - (G) Relative search efforts.
 - (H) Training of adoptive parents, foster youth, or mentoring families.
 - (I) Mediation services.
 - (J) Facilitation of siblings in the same placement.
 - (K) Facilitation of postadoption contact.
 - (L) Engaging youth in permanency decisionmaking.
 - (M) Any service or support necessary to resolve any identified barrier to adoption.
 - (2) The services specified in paragraph (1) may be provided directly by the county, contracted for by the county, or provided through reimbursement to the family, as approved by the county.
 - (c) The amount of funding provided in the appropriation of funds provided by the annual Budget Act to each county participating in the project shall be allocated as follows:

- (1) Seven hundred fifty thousand dollars (\$750,000) to the City and County of San Francisco.
- (2) One million two hundred fifty thousand dollars (\$1,250,000) to the County of Los Angeles.
- (3) A total of two million dollars (\$2,000,000), to be awarded to the two additional counties and the district office selected pursuant to subparagraph (C) of paragraph (3) of subdivision (a), minus any funds subtracted by the department for the purpose of administering the project. The amount of funds provided to the department for administration of the project, including the costs of collecting and analyzing data pursuant to subdivision (h) and developing the information pursuant to subdivision (i), shall not exceed three hundred thousand dollars (\$300,000).
- (4) If the appropriated amount in the annual Budget Act differs from the total amount specified above, then the funds shall be distributed in the same proportion as the amounts listed in paragraphs (1) to (3), inclusive.
- (d) Funds shall be allocated to the counties pursuant to subdivision (c) no later than January 1 of each year, and shall remain available for expenditure for three years.
- (e)
 - (1) The department shall seek approval for any federal matching funds that may be available to supplement the project.
 - (2) The implementation of the project shall not be dependent upon the receipt of federal funding.
 - (3) Project funds shall supplement, and not supplant, existing federal, state, and local funds, and shall be used only in accordance with the terms and conditions of the project.
 - (4) No expenditure made for services specified in subdivision (b) may be made to the extent that it renders the family ineligible for federal adoption assistance.
- (f) The project shall be implemented only upon the adoption of a resolution adopted by each county board of supervisors.
- (g) The department shall work with the counties to develop the requirements for the project, including the number of families that may participate in the project, given the available resources, and guidelines for data collection, as required by subdivision (h).
- (h)
 - (1) The department shall work with the participating county and the state district office to analyze the effects of the project.
 - (2) Measures assessed by the state and counties shall include, but shall not be limited to, the following:
 - (A) The extent to which the adoptions of the targeted population identified in paragraph (1) of subdivision (a) increased as a result of the project.
 - (B) The number of families and children served by the project.
 - (C) The type and amount of preadoption and postadoption services that were provided to children and families under the project.
- (i) The department shall provide information to the Legislature on the results of the project by November 30, 2010.
- (j) Adoption programs in the project counties shall be encouraged to create public-private partnerships with private adoption agencies to maximize their success in improving permanent outcomes for older foster youth.
