
Attached is an updated list of Intercounty Transfer (ICT) Coordinators for all counties. It has also been requested that we remind counties that the ICT Coordinator is designated to handle exceptional problems only. An attempt should be made to resolve problems with involved eligibility workers before contacting the coordinator.

For the list to be most helpful, it is important that it remain as current as possible. We would appreciate timely notification of any change in your designation of ICT Coordinator. An updated list will be published every six months or more frequently if warranted by the number of changes.
