**SUBJECT: CIVIL RIGHTS REGULATIONS TRAINING (MPP-DIV. 21)**

**REFERENCE: DSS MANUAL LETTER No. 81-24**

Division 21 Regulations have recently been revised to reflect changes in federal and state requirements relating to nondiscrimination in the provision of services to applicants and recipients, and to clarify language relating to the responsibilities of the Department of Social Services (SDSS) and the county welfare departments in providing those services.

Several county welfare departments have expressed the need for an orientation program addressing the revisions to Division 21. Accordingly, the Civil Rights Bureau will provide training in the locations shown on the attached schedule. All county Civil Rights Coordinators are requested to attend. In addition, Staff Development Officers and personnel actively involved in civil rights issues, including the training of public contact staff, should attend.
