SUBJECT: ALIEN VERIFICATION FORM, TEMP CA 6 (Attachment)

REFERENCE: ALL COUNTY INFORMATION NOTICE I-139-81

The purpose of this letter is to clarify instructions provided in the referenced All County Information Notice concerning use of the Temp CA 6 (Attachment) for Food Stamp applicants.

The Temp CA 6 (Attachment) reflects program eligibility categories for aliens which will be effective January 1, 1982 when food stamp regulations eliminating presumptive eligibility for aliens are implemented. These program eligibility categories also reflect current regulations with one exception. If a Temp CA 6 (Attachment) is returned by INS prior to the implementation of these regulations and box 3b (clarification of alien's status is still in process) is checked, the alien will continue to be eligible for Food Stamps, as well as for AFDC and Medi-Cal.

INS has been directed not to use check-box 3b when clearing the current backlog of CA 6's. However, in the event that a Temp CA 6 (Attachment) is received from INS and box 3b is checked, existing regulations should be followed when determining program eligibility.
