SUBJECT: TERMINATION OF AID TO FAMILIES WITH DEPENDENT CHILDREN-FOSTER CARE
(AFDC-FC) FUNDS TO CERTAIN GROUP HOMES

The Foster Care Rates Bureau has notified certain group home providers of the potential that AFDC-FC funds would no longer be available for children placed in these homes. Some of these group homes have failed to comply with requirements of Operations Policies and Procedures (OPP) Sections 11-402.412(a), 11.402.413, and 11-402.414 which require that a completed AFDC-FC group home rate request be submitted to the Foster Care Rates Bureau within specified time frames. Others have notified this office that they have gone out of business or are no longer accepting AFDC-FC funded children.

The attached lists group home providers whose AFDC-FC funds shall be terminated effective the date shown for each. If your agency is currently using or planning to use one of these group homes for an AFDC-FC funded placement, please be advised that AFDC-FC payments can no longer be made after the date shown. Funding for these providers may be resumed for Fiscal Year 1985-86 if a rate request based on 1984 costs is completed within specified time frames and a rate is set.
