TO: ALL-COUNTY WELFARE DIRECTORS

SUBJECT: CALIFORNIA STATE PLAN ON AGING

The State of California is committed to serving its older persons and functionally impaired adults through the development and enhancement of community-based systems of care that encompass a broad scope of services. The State Department of Social Services (SDSS) shares this commitment and seeks to identify ways in which the delivery of services to the adults who need them, can be improved.

The Health and Welfare Agency has requested that other State departments support the California Department of Aging (CDA) in the development of the 1989-93 State Plan on Aging which is required by the Older Americans Act and the Older Californians Act. The CDA plan will address goals and implementing objectives for developing community-based systems of care for California's older persons and certain functionally impaired adults during the 1989-93 period.

At the local level, the Department of Aging has designated 33 geographical Planning and Service Areas (PSAs) in which services to seniors are coordinated by Area Agencies on Aging (AAAs). The AAAs are currently in the process of developing individual PSA Plans for the 1989-93 planning period. These Plans will focus on the incremental development of community-based systems of care.


Since the Older Americans Act mandates that AAAs must coordinate services to seniors in their PSAs, County Welfare Departments (CWDs) are encouraged to coordinate with the AAAs regarding participation in this planning effort. Attached for your reference is a list of the California Department of Aging's 33 Area Agencies on Aging.

The Department of Aging has advised us that your involvement in the development of the PSA Plans may include setting goals in the adult services programs to be included in the PSA Plan that will contribute to the establishment of community-based systems of

care. Such goals should be consistent with existing CWD goals and objectives which have been developed as a result of SDSS policy, regulations, and fiscal restraints. There will be no new SDSS resources to cover any activities which may be generated by this planning process. It is recommended that CWDs work with AAAs through joint Memorandums of Understanding (MOUs) to meet local service needs in a coordinated fashion.

Thank you for your efforts, assistance, and cooperation with your County's AAA in the development of community-based systems of care for California's older persons and functionally impaired adults. Your efforts are very much appreciated, and will greatly benefit the adults in your County who require these services.
