As we develop strategies to enhance our productivity and communication with our stakeholders, the World Wide Web is an avenue of communication we can all benefit from. What does this mean for you? Better service and greater access to information. If you have an Internet connection, you will be able to immediately view or download these documents in Adobe Acrobat "PDF" format. An on-line index will be provided as a reference, as well as instructions explaining how to obtain previously released letters or notices that are not yet available in the new electronic format.

Effective Monday, June 1, 1998, all letters and notices will be available in electronic format only. As we work to accommodate those recipients without Internet access, traditional paper copies of these documents will continue to be available only through special arrangement.

Enclosed is a mailing list information survey card (GEN 1310). Please complete this card and return it to us as soon as possible. Our ultimate goal is to let you know by electronic mail (e-mail) whenever new letters or notices are issued. You can then view, download, and print the documents yourself, using Adobe's free Acrobat Reader software. If you do not have access to e-mail or the Internet, please be sure to clearly indicate that fact on the card.




