REFERENCE: ALL COUNTY LETTER (ACL) No. 11-79

The purpose of this erratum is to correct a typographical error to ACL No. 11-79 on page four, under the heading Reconsideration of an ICPC Denial. The last sentence incorrectly reads, "If the receiving state decides to change the prior decision denying the placement, an ICPC transmittal letter and a new ICPC 100A must be signed and sent to the *receiving* state reflecting the new decision." Instead, it should read, "If the receiving state decides to change the prior decision denying the placement, an ICPC transmittal letter and a new ICPC 100A must be signed and sent to the **sending** state reflecting the new decision."
