SUBJECT: CALIFORNIA WORK OPPORTUNITY AND RESPONSIBILITY TO KIDS  
(CalWORKs): CASH AID AND PREGNANCY SPECIAL NEEDS (PSN)  
FOR PREGNANT WOMEN WITH NO OTHER ELIGIBLE CHILDREN

REFERENCE: ASSEMBLY BILL (AB) 1579 (CHAPTER 632, STATUTES OF 2014);  
AB 1640 (CHAPTER 778, STATUTES OF 2012); WELFARE AND  
INSTITUTIONS (W&I) CODE SECTION 11450(b)(1); ALL COUNTY  
LETTER NO. 14-04; MANUAL OF POLICIES AND PROCEDURES  
(MPP) SECTIONS 42-711, 42-712, and 44-211.6

The purpose of this letter is to provide instructions to County Welfare Departments (CWDs) regarding the implementation of AB 1579, which is effective July 1, 2015. AB 1579 provides that a pregnant woman age 19 or older, with no other eligible children in the home, may be eligible for CalWORKs cash aid and \$47 in pregnancy special need (PSN) payments beginning in the second trimester of pregnancy. The second trimester begins at the six month period immediately prior to the month of the anticipated birth. For example, if the birth is anticipated in July, the second trimester would begin in January. Consistent with existing law, eligibility begins after verification of pregnancy is provided.

Prior to the passage of AB 1579, a pregnant woman age 19 or older with no other eligible children in the home was eligible for CalWORKs cash aid and PSN payments beginning in the third trimester of pregnancy, pursuant to MPP Section 44-211.6.

As a reminder, ACL No. 14-04 provides instructions regarding changes in eligibility for pregnant teens, age 18 or younger. AB 1640 (Chapter 778, Statutes of 2012) expanded eligibility for a pregnant teen, age 18 or younger, with no other eligible children, and who had graduated from high school or obtained a high school diploma or its equivalent. Prior to the passage of AB 1640, such pregnant teens would not be eligible for CalWORKs or PSN payments upon verification of pregnancy, unless eligible for the Cal-

Learn program. Under AB 1640, they are eligible for CalWORKs and the PSN payments at any time upon verification of pregnancy, and do not have to wait until the beginning of the second trimester.

Existing rules regarding Welfare-to-Work (WTW) participation requirements and exemptions will continue to apply to pregnant women with no other eligible children, including those who now qualify for CalWORKs cash aid in the second trimester of their pregnancy, pursuant to this implementing ACL. Information on WTW participation requirements and exemptions can be found in MPP Sections 42-711 and 42-712, respectively. Further information regarding the WTW exemption based on pregnancy will be forthcoming under separate cover.

### **Noticing Instructions**

An updated Notice of Action message is attached to this letter to reflect the change in eligibility rules. The updated "M82-820A (3/15): No Eligible Person, Deny" is a required form and no substitute is permitted. Required forms may not be modified or restructured by CWDs. However, overprinting or reformatting under the conditions outlined in MPP Operations Manual Section 23-400.211, Overprinting Required Forms, and Section 23-400.212, Electronic Data Processing Modifications, is permitted.

Automation systems may need to be modified to allow CWDs to send the updated M82-820A using the NA 290 (2/14) when appropriate. Until consortia are able to automate these forms, CWDs will have to implement these forms manually.

or notice along with the [GEN 1365 \(3/08\) - Notice of Language Services](#) and a local contact number.

The CWDs shall ensure that effective bilingual services are provided. This requirement may be met through utilization of paid interpreters, qualified bilingual employees, and qualified employees of other agencies or community resources. These services shall be provided free of charge to the applicant/recipient. In the event that CDSS does not provide translations of a form, it is the CWD's responsibility to provide translation services if an applicant or recipient requests it.
