The purpose of this letter is to inform you effective January 21, 2008, counties are to suspend submission of the Stage One Child Care 24-month eligibility biennial report, form CW 2197, to the California Department of Social Services (CDSS). The CW 2197 report for December 2007 will be the last report that counties are required to submit to CDSS until further notification.

The CW 2197, formerly known as the TEMP 2187, is a "Timing Out" Questionnaire with actual and projected information on the number of children and families receiving Stage One Child Care who have reached or who will reach the end of the 24 month limit of child care services for which former CalWORKs recipients are eligible. The data being collected in this format is no longer required. CDSS staff is using alternative resources to acquire necessary data.
