SUBJECT: GREEN V. OBLEDO: POSTPONEMENT OF IMPLEMENTATION


REFERENCE:

This letter serves to inform you of a postponement in implementation of the above-referenced court decision. As you are aware, planned implementation was to begin March 1, 1984. However, the plaintiff's attorney in Green has requested that the Notice of Action (NOA) explanations for Green be reviewed by the newly-hired Turner consultant. The Department has agreed to honor that request in an effort to ensure that the explanations sent claimants are as comprehensive as possible to the AFDC recipient population and to avoid the possibility of any further litigation on the matter.

Because there are numerous NOA's in Green, we cannot anticipate the length of time which will be needed to review them. For this reason and due to our inability to anticipate the extent of the changes which may be suggested by the consultant, the Department cannot at this time project a revised implementation date for Green. You will be informed of the revised implementation date upon completion of the consultant's review.

Please note that the information you have received to date for Green remains valid and will be used when Green is implemented. Items will be amended only where dates, such as the final filing date for claims, appear. Attachment I provides a list of the information/items you should already have. Attachment II provides a list of the remaining information/items which will be forwarded, simultaneously, at a later date.
