The purpose of this letter is to provide counties with reproducible copies of the revised Balderas Reminder Notice (CA 1027, Message number M40-181C) in both English and Spanish.

As required by the May 1, 1987, Turner Implementation Standard formatting requirements, the CA 1027 has been revised to reflect the approved Turner format. The message language itself has not been changed.

Counties using an automated system must print the message in the appropriate format. Counties may either print both check boxes or only the circumstance that applies.

Also included is an updated AFDC NOA Handbook page for the English message. Additional copies will be distributed through the regular Handbook Updating process.
