SUBJECT: UPDATE TO THE EXCLUSIONS LISTING FOR THE IN-HOME
SUPPORTIVE SERVICES (IHSS) PROGRAM

REFERENCE: ALL COUNTY LETTERS (ACL) NO. 91-66, NO. 91-91,
NO. 91-121 AND 92-25

This is to provide Counties with an update to the notification of individuals who are excluded from participation and are ineligible for reimbursement with Title XVIII (Medicare) or Title XX (Social Services Block Grant) funds which are used to provide IHSS services. This is a regular update of sanction notices received from the United States Department of Health and Human Services and should be incorporated in the listing forwarded in ACL No. 91-66 released July 15, 1991, ACL No. 91-91 released September 6, 1991, ACL No. 91-121 released December 2, 1991 and ACL No. 92-25 released February 21, 1992.

All recipients of this ACL should check their systems to determine whether any excluded physician/practitioner, provider or other health care supplier is being reimbursed for services provided subsequent to the date they were excluded from participation in the Medicare program.
