The purpose of this letter is to inform counties of a redistribution of \$636,621 in FY 2008-09 CalWORKs Single Allocation funding. These funds are being redistributed as requested by the County Welfare Directors Association (CWDA). The CWDA determined the redistribution of funding amongst counties to ensure the maximum expenditure rate of available funds. The attached spreadsheet displays the redistributed FY 2008-09 CalWORKs Single Allocation funds.

Please note that the redistributed funds have been added to the counties' total Single Allocation rather than to any of the individual components within the allocation. Counties have the flexibility to use the funds interchangeably between individual components.
