The purpose of this letter is to inform counties of a redistribution of \$11,875,146 in FY 2009-10 CalWORKs Single Allocation funding. These funds are being redistributed as requested by the County Welfare Directors Association (CWDA). The CWDA determined the redistribution of funding amongst counties to ensure the maximum expenditure rate of available funds. Attachment I displays the redistributed FY 2009-10 CalWORKs Single Allocation funds. For informational purposes only, it also displays a redirection of \$12,000 and \$40,000 in CalWORKs Single Allocation funds to Santa Clara County, which is administering a contract on behalf of all counties for a consultant to provide statewide coordination of county implementation activities for the Temporary Assistance for Needy Families Emergency Contingency Fund, as listed in CFL No. 09/10-12E and 09/10-58, respectively.

Please note that the redistributed funds have been added to the counties' total Single Allocation rather than to any of the individual components within the allocation. Counties have the flexibility to use the funds interchangeably between individual components.
