WORK OPPORTUNITY AND RESPONSIBILITY TO KIDS  
(CalWORKs) SINGLE ALLOCATION – CHILD CARE RESERVE

The purpose of this letter is to inform counties of an augmentation to the FY 2005/06 CalWORKs Single Allocation. The allocation has been increased as a result of the Department of Finance's approval of a request for funds from the Child Care Reserve. A total of \$3,740,293 in Child Care Reserve funds is being allocated to counties that demonstrated a need for additional child care funds. Demonstrated need was determined by comparing each county's FY 2005/06 CalWORKs Child Care allocation and Single Allocation to actual and projected expenditures. The attachment displays counties' Child Care Reserve allocation and revised total FY 2005/06 CalWORKs Single Allocation.
