

TRENDS

- The number of CalWORKs cases increased 0.6% between August 2008 and September 2008.
 - 0.9% increase in One-Parent cases
 - 0.4% increase in Child-Only cases
 - 0.9% increase in Two-Parent cases
- The number of CalWORKs cases increased 5.9% between September 2007 and September 2008.
 - 7.2% increase in One-Parent cases
 - 4.2% increase in Child-Only cases
 - 14.8% increase in Two-Parent cases
- The overall caseload has declined 48% since March 1995, the highest point in California's caseload.
- California's caseload has declined 43% since December 1, 1996, when California's Federal Temporary Assistance for Needy Families Program began.
- California's caseload has declined 34% since January 1, 1998, when California's CalWORKs Program began.
- California's caseload has declined 18% since October 1, 1999, when California's Separate State Program began.
- Effective January 1, 2003, Safety Net cases are those which the adults are discontinued and removed from the assistance unit due to the CalWORKs 60-month time limit. Only children are aided in these cases and are converted from the case categories Two-Parent, One-Parent or TANF Timed-Out.
