

CalWORKs Caseload by Category October 1999 - July 2000



August 1998 - July 2000


















Food Stamp Program Public Assistance and Nonassistance Households August 1998 - July 2000

Food Stamp Program Households Also Receiving Public Assistance August 1998 - July 2000



Food Stamp Program Nonassistance Households August 1998 - July 2000


